

GAMBLING DEVICES ORDINANCE

Ordinance No. 436

AN ORDINANCE AMENDING CHAPTER 600 AND CHAPTER 605 OF THE ORDINANCES OF THE CITY OF VAN BUREN, MISSOURI TO INCLUDE AN EXPRESS PROHIBITION OF GAMBLING DEVICES WITHIN THE CITY OF VAN BUREN, MISSOURI.

WHEREAS, the State of Missouri has made it unlawful to possess a gambling device and implemented penalties for the violation of such statute.

WHEREAS, it has been deemed necessary by the City of Van Buren, Missouri to ensure that it's Municipal Code is consistent with Missouri statutes.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE CITY OF VAN BUREN:

Section 1. Chapter 600 shall be amended to include a new section numbered 600.075, which shall read as follows:

SECTION 600.075: GAMBLING DEVICES

- A. No licensee under this chapter shall allow upon or about his/her licensed premises any gambling of any kind or character whatsoever, in which the one who plays stands to win or lose money, trade checks, prizes, merchandise or any other consideration whatsoever. No licensee shall possess any slot machine or any other gambling devices upon his/her licensed premises whereby money, trade checks, prizes, merchandise or property or any other consideration whatsoever may be won or lost.
- B. It shall be unlawful to lease, permit, or otherwise allow another person to place or maintain a slot machine or any other gambling device upon licensee's property.
- C. Violation of this section shall be punishable in accordance with section 100.220. In addition to any other penalty imposed, each violator of this section shall be subject to the revocation of and refusal to further issue any license under this Chapter.

Section 2. Chapter 605 shall be amended to include a new section numbered 605.075, which shall read as follows:

SECTION 605.075: GAMBLING DEVICES

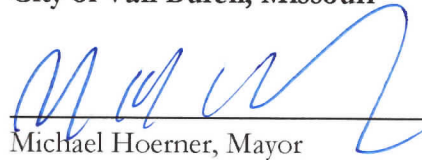
- A. No licensee under this chapter shall allow upon or about his/her licensed premises any gambling of any kind or character whatsoever, in which the one who plays stands to win or

lose money, trade checks, prizes, merchandise or any other consideration whatsoever. No licensee shall possess any slot machine or any other gambling devices upon his/her licensed premises whereby money, trade checks, prizes, merchandise or property or any other consideration whatsoever may be won or lost.

- B. It shall be unlawful to lease, permit, or otherwise allow another person to place or maintain a slot machine or any other gambling device upon licensee's property.
- C. Violation of this section shall be punishable in accordance with section 100.220. In addition to any other penalty imposed, each violator of this section shall be subject to the revocation of and refusal to further issue any license under this Chapter.

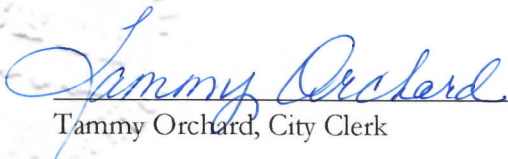
